- Dean Hanson:
 - Efforts to nominate Fr. Stephen for Chaplain of the Year using technology provided by Nick Cumberland using Google Forms.

Proposed Budget for Fiscal Year:

Dominic led a detailed discussion on the proposed budget for the coming fiscal year. This was for the first required vote of the budget and the next and final vote will be taken during the next business meeting. Key points of discussion included:

1. Foreign Missions:

- Brandon suggested focusing more funds locally rather than on foreign missions.
- George argued that money goes further in third-world countries, providing more significant help.
- Steve suggested considering funds for an upcoming Mexico mission.

2. Stipend/Rent to Fr. Stephen for parish facility use:

Proposed but not approved.

3. General Mission Funds:

- Dean suggested one line item for missions, which can be allocated throughout the year as needed.
- George proposed a \$2,500 line for general missions.

4. Christmas Party:

Suggested to lower the cost.

5. **Budget Summary:**

 Dominic emphasized a 0 balance budget to ensure funds are used efficiently. Discussion included the necessity of careful planning for fundraising to cover essential expenses like smoker repairs.

6. **Budget Approval:**

- Ed motioned to accept the budget as presented, with changes discussed.
- George seconded the motion.
- The budget was approved by a majority vote, though some debate remained.
